

# **PUBLIC FISHING ACCESS Harker's Island / Straits Landing**

The NCDOT recently replaced the draw bridge connecting Harkers Island to the mainland and left a partial remnant of the old bridge as a public access fishing pier. This is in addition to the existing wooden pier on the opposite side of the roadway. Access is available thru the NCWRC Straits Landing Boat Ramp. Parking is available. This makes a previously boat accessible trout hole within casting distance. This is a VERY popular local spot for Fall Fishing.

Straits Fishing Pier - Carteret County, NC

The Straits Fishing Pier project is owned by Carteret County NC and provides water access to thousands of locals and tourist year round. The "Straits" area is well known for superior inshore fishing and beautiful waters just a short distance from Cape Lookout. The project included demolition of an existing pier structure and the complete redesign and permitting of a new, modern, ADA Accessible and far more resilient product. Boasting over 10,000 sqft of finished pier area, stainless hardware and concrete decking this project was a superior investment into the community.

### **AUGUST FISHING REPORTS**

From Chris DiGiovanna: Aug 31st - Launched at Oriental in search of drum. Caught a number of small bluefish inside of AR -396. Fished deeper water (22') in the channel and got a single drum bite (rig broke at the crimp next to the kayak). Landed a nice 23" bluefish on a piece of drifted cutbait.

Sep 1st - fished the Haystacks in Moreshead City. Caught a 16" speckled trout on a mirrorlure and a variety of species on soft plastics. Jess caught a 20" puppy drum hopping a 3" Z-man MinnowZ on the bottom in a deep channel. Hot color was purple w/ chartreuse tail.

The N.C. Marine Fisheries Commission Commercial Resource Fund Committee and the Funding Committee for the N.C. Commercial Fishing Resource Fund will meet jointly on Sept. 12 at 11 a.m. The meeting will be held at the N.C. Department of Environmental Quality's Washington Regional Office, 943 Washington Square Mall, Washington.

Members of the public may attend the meeting in person or by web conference. A meeting agenda and WebEx link can be found here.

Public comment will not be accepted during the meeting.
Online comments from the public will be accepted until 4:00 pm on September 11 using the link provided below.

The Commercial Fishing Resource Fund is composed of a portion of the proceeds from the sale of the commercial fishing

licenses issued by the North Carolina Division of Marine Fisheries (NCDMF). The N.C. General Assembly created the

fund to support the development of sustainable commercial fishing in the State. The committees will hear a report at this meeting on proposals received from its 2024 Request for Proposals.

Comments Prepared by Stuart Creighton, CCA NC Fisheries Committee Chairman:

Members of the CFRF Committee will be meeting this week to discuss several items. Perhaps most significant among them is a proposed study "to examine the benefits of trawling in the sound or rivers."

Let's be clear: the defining objective of this study is without merit.

Let's be even more clear: THERE IS NO BENEFIT TO TRAWLING IN THE RIVERS OR SOUNDS.

Numerous studies have already been done and the overwhelming conclusion is that trawling is a very destructive method of fishing. It is a wasteful practice that, at minimum, destroys key habitats, damages benthic ecosystems, annually wastes countless numbers of juvenile finfish, re-suspends sediments laden with heavy metals, and releases previously sequestered atmospheric carbon.

Furthermore, to purposefully set the parameters of this potential study ABOVE THE FERRY LINES on rivers where significant gear restrictions are already in place is a direct attempt to interfere with an area that is finally recovering from decades of commercial over-exploitation.

Do not forget that the trawlers were removed from these areas years ago because of the incredible damage that they did to numerous species of finfish and shellfish in these important nursery areas. To allow any trawling in these areas would literally muddy the waters with regards to the important study that DMF should be conducting right now with regards to striped bass recovery.

In addition, performing this study in such a way that would be scientifically valid, would prove to be enormously complex. To assess the impacts of trawling, a preliminary assessment of the infauna and epifauna in control areas, experimental areas, and

trawled areas must first be made. Oyster habitat, areas of SAV, and other important habitats must be avoided. Otter trawls have heavy doors and tickler chains that disrupt the bottom. Any study that fails to sample and quantify the organisms that live in and on the sediments of trawling in these habitats.

Failure to sample the area before and after the trawl invalidates the study.

Study tow times that do not mirror customary tow times invalidate the study.

Using tailbag mesh sizes different than industry standard invalidates the study.

The number of variables that must be concurrently addressed makes obtaining any scientifically meaningful results from this potential study highly unlikely. When compared to the damage it could do, this study should not be initiated.

Also, it cannot be understated just how unnecessary this proposed study is. Trawling above the ferry lines was stopped, initially, because of concerns over undersized Southern flounder discards from crab trawling. Discards were very high, the gear could not be modified to reduce the discards, and the practice was stopped in these same areas. Later investigations resulted in halting shrimp trawling above the ferry lines (and limiting headrope length in others) because of the damage trawling was doing to these habitats.

The kinds of fish and their sizes in these areas is already known.

The bottom type and resulting benthic ecosystem are already known.

Sampling in these areas is continuously done by numerous fishery independent programs run by the Division.

The function of these areas as key primary, secondary, and/or special secondary nursery areas is already known.

In conclusion, I cannot stress enough the importance of the Division NOT SUPPORTING this study. The Division would do well to remember their own mission statement: "The Division of Marine Fisheries is dedicated to ensuring sustainable marine and estuarine fisheries and habitats for the benefit and health of the people of North Carolina." If you are, in fact, about this mission, then DO NOT support this study. DO NOT approve any study areas, DO NOT grant any permits, DO NOT commit any personnel which allows the NCFA to perpetrate this charade. This study is nothing short of an absolute farce and should be treated as such.
